



**Equine Activity Sponsor Release, Covenant Not to Sue and Assumption of Risk**

Know all men by these presents, that I, \_\_\_\_\_, who resides at \_\_\_\_\_ (hereinafter referred to as "Participant") on my behalf and on behalf of my heirs and successors in interest:

- a) Desire to engage in and does hereby engage in the following equine activity to wit: any activity involved with Cavallo Farms (hereinafter referred to as "Equine Activity Sponsor"), including Amy O. Center, Janet Cawley, Janam Enterprises, Inc., JAHF, Inc., JAHF Properties Ltd. LLLP, and their representatives, employees, and agents on or off the property located near the intersection of Interstate 10, State Road 59 and Main Street, Lloyd, Florida; and
- b) Acknowledge that I am personally aware of the inherent and potential danger of injury or loss associated with riding and being in the presence of horses and the equipment related to those endeavors; and
- c) Expressly agree to assume the risk for any and all injury or loss caused by or contributed to by riding or being in the presence of horses and the equipment related to those endeavors; and
- d) Expressly covenant not to sue or make claim against the Equine Activity Sponsor for damages for injury or loss caused by or contributed to or in any way arising out of riding or being in the presence of horses and the equipment related to such endeavors; and
- e) Agree to forever and finally hold harmless, indemnify, release, remise, acquit, satisfy and forever discharge release the Equine Activity Sponsor from any and all manner of action and actions, cause and causes of action, suit, debts, dues, sums of money, bonds billings, contracts, controversies, agreements, promises, damages, variances, judgments, executions, claims and demands whatsoever, in law or in equity, which may arise or might in the future arise or hereinafter may arise for damages for loss or injury caused by or contributed to or in any way arising out of riding or being in the presence of horses or the equipment related to such endeavors; and
- f) Understand and agree that the Equine Activity Sponsor together with their care will not be responsible for damage, injury, or loss to or by animals or equipment in their care. This includes, but is not limited to; fire, theft, animal collision, escape, and acts of God.

This release is given freely and voluntarily by the Participant and is meant to remain in existence throughout the duration of the equine activity. Signing this document constitutes a full and complete waiver of any and all legal rights and remedies that may be otherwise available.

**Warning**

***Under Florida law, an equine activity sponsor or equine professional is not liable for an injury to, or the cause of death of, a participant in equine activities resulting from the inherent risks of equine activities.***
